1. Capacity Building

a. Capacity building need assessment

We submitted our capacity assessment on April 30, 2020.

b. Capacity building program design

The capacity building program design will be updated and refreshed as needed.

c. Capacity building program delivery

We continue to serve in a coordinating role with the three counties' fire safe councils. Several drafts of a letter to the counties' boards of supervisors were produced and vetted through the group of fire safe councils. In the midst of this process, we attended a meeting of all interested fire safe councils convened by California Fire Safe Council. The letter was eventually finalized and brought before the Mono Board of Supervisors in October, where it was very well received and spurred some excellent discussion. We are still working on getting the letter agendized in Inyo County, and it is unlikely to go before the Alpine Board of Supervisors.

Rick and Holly served in a central role in the development of Mono County's county fire

coordinator grant application through CFSC. We produced drafts of all the portions of the application that did not require county-specific knowledge. We also consulted in an informal way on the Inyo County application but did not assist with the actual writing of the proposal.

2. Collaboration and Partnership Development

a. Stakeholder and partner outreach

We have recognized that Alpine County issues tend to be left out of discussions of projects, project prioritization, and other efforts. Alpine Watershed Group reached out to SNC, and we then reached out to AWG to discuss how to bring more resources to the county, possibly through early action funding but also using current resources. We are also in regular contact with Alpine Fire Safe Council and Alpine Biomass Collaborative but have not yet found a way to formally partner on any activities.

We have been reaching out to local jurisdictions (including Alpine County) about the possibility of a structure hardening demonstration project in the region. The outreach has been met with some interest and some non-responsiveness. We are investigating the possibility of FEMA/CalOES funding.

d. Collaborative activities

Collaboration took place with the ESCCRP effort, both directly with Janet Hatfield and through the outreach & education and monitoring & research needs assessment focal teams. This work includes frequent communication with Janet and her team, participation in various meetings, and contributing in a substantive way to the project's needs assessment.

We collaborated with the region's fire safe councils in developing and submitting a letter to the boards of supervisors.

Through the awarding of two CAL FIRE fire prevention grants, we have started working more closely with 40 Acres FSC, though the bulk of that work will not begin until January 2022 (and will also include Independence FSC).

- 3. Forest Health and Fire Protection Project Planning
 - a. Collecting existing plans and project information

No progress was made here during the reporting period.

b. Designing the planning process

We had a call with Great Basin Institute during the quarter. They have been backed up with other work, so all they could share with us was a map of the study area. They said they are working on the content of the analysis now and will have something for us to review towards December. We discussed then having a workshop with the full stakeholder group to present the document and describe how it can be used.

c. Outreach and involvement of stakeholders and the public

We worked with various stakeholders through the ESCCRP in planning its initial forest health project. In a related vein, the Whitebark Institute was awarded a small grant through Southern California Edison to perform defensible space and home hardening education in Mammoth Lakes over the next year.

We received word during the reporting period that the Whitebark Institute was awarded two CAL FIRE fire prevention grants, which will allow us to work with the communities of 40 Acres and Independence. We communicated all three awards to the full RFFCP stakeholder group. Once grant agreements are signed, we will also be preparing press releases for the affected communities and for media outlets.

d. Application of scientific methodologies or best practices

e. Project prioritization

American Forests is continuing to facilitate our project prioritization process. The project prioritization subcommittee developed indicators that could then be narrowed into criteria. The subcommittee did the narrowing through a survey, and then we met with the full RFFCP stakeholder group to go through an indicator prioritization exercise. Because only a handful of stakeholders was able to stay on the call long enough to complete the exercise, we made the exercise available to additional stakeholders in electronic form. In all, 14 people went through the prioritization exercise. We have reviewed the results and are working with American Forests on next steps, which will likely include first vetting the results (and the process) through the subcommittee before taking them to the full stakeholder group.

As mentioned above, we have obtained three grants for fire prevention work in the eastern Sierra. The work of these grants will start in late 2021 and early 2022.

We communicated an early action RFFCP funding concept proposal to SNC, which includes project development needs.

We are looking into CalOES/FEMA Hazard Mitigation Grant Program funding for a possible structure hardening demonstration project in all three counties.

We are concentrating our efforts for this deliverable on the Eastern Sierra Wildfire Alliance website. Plumas Corporation's Sierra Corps Fellow is helping to build out the pages focused on education.

Deliverable 4: Develop sub-regional plan

We have begun to write the sub-regional plan, and with the recent progress on the project prioritization process, will soon have a list of prioritized projects to include in the plan.

- The fire safe council letter was presented to the Mono County Board of Supervisors in October.
- Rick and Holly continued to participate in the ESCCRP effort, including leading the outreach & education and research & monitoring focal teams of the needs assessment.
