September 18 Full ESWA Outcomes to Build On:

- Collaborative Focus
 - Both Communities & Landscapes
- Decision-making
 - Modified consensus model
- Organizational Structure
 - Steering Committee, sub-committees, membership, etc.
- Non-binding documentation of partnership
 - Memorandum of Understanding or Agreement
 - Recommend key elements from other collaborative models
 - Documents/ outlines: Focus, Structure, Decision-making
- Tribal Inclusion & Partnership
 - Need to work on this

Gov. Subcommittee Recommendations

Organizational Structure

- Steering Committee: smaller group that handles administrative issues, meeting preparation, routine decisions
- General membership w/ regular open meetings
- Sub-committees or working groups, topic-focused

Decision-Making

- Consensus-seeking
- Defined objection criteria

Membership/ Partnership Documentation

- Memorandum of Understanding
- Non-binding
- Include Federal Partners
- Outlines: Focus, Structure, Membership, Meetings, Decision-making, etc.

Tribal Inclusion & Partnership

- Share ESWA work with individual tribes
- Work to improve inclusion and representation

What decisions will ESWA make?

- Near-term foundational issues for development of the collaborative
- Project prioritization, inclusion
- Policy, issue support

Does ESWA support a consensus-seeking approach?

- Establish consensus voting guidelines: Consensus ranges from support to abstain or stand aside; Set time frame for voting and decision-making
- Establish approval process for "consent" items
- Members can use an established blocking criteria and process to delay decision if they cannot stand aside or abstain

Blocking Criteria: What works for ESWA?

- Blocking criteria are the rules or standards by which a member can stop or delay a decision
- Criteria should be clear, limited and reflect the groups mission and values
- Criteria discussed by governance committee: Tribal request, local impact

Assumptions

- Nonbinding beyond the scope of collaborative membership (you can leave)
- No financial commitment
- Agreement and organizational structure are adaptive—they can change as ESWA's needs change
- Formal agreements exist among partners for project implementation, planning, etc (example: Whitebark Institute and Inyo National Forest for ESCCRP implementation)

Should the Governance Subcommittee continue working on...

- Memorandum of Understanding for ESWA membership?
- Assure the MOU allows for federal land management agencies to join?
- Have the MOU contain:
 - Purpose and scope
 - Guiding Principles, Mission/Vision/Goals
 - Organizational Structure, Member Roles and Responsibilities
 - Decision-Making Process



Committee Goals:

 Identify communication gaps and make recommendations for internal communications tools and platforms

Current Committee Tasks

- Consider internal communications gaps and needs
 - Contact List
 - Partner Updates
 - Grant Collaboration

Comms Subcommittee Recommendations

Contact Database

 Collaborate with Projects Subcommittee to develop comprehensive contact database

 Streamline partner updates by gathering them through a form and distributing them in a regular newsletter.





 - 2. Full ESWA start gathering project details






Eastern Sierra Communities Wildfire Defense Program grant:



Amount: \$4.6 Million

Timeframe: 5 years

Purpose: Funds staffing, organizing, and implementation of a sustainable, two-county, local communities' hazardous fuels removal program



Applicant: Eastern Sierra Council of Governments

- Subawards for Invo and Mono Counties
- Contracts for fuel reduction crews
- Equipment purchases
- Staffing capacity in ESCOG

Competitiveness: 58 out of 573 applicants funded nationwide

Grantor: US Forest Service \$1 billion five-year competitive Community Wildfire Defense Grant (CWDG) Program funded by the Infrastructure Investment and Jobs Act

Partners: Inyo & Mono Counties, Tribes, Fire Safe Councils / Firewise Communities, CAL FIRE, USFS, BLM, Local Fire Depts, Whitebark Institute, Cerro Coso College






